Introduction

As Accounting Officer for Vote 8, I am required each year to prepare the appropriation account for the Vote, and to submit the account to the Comptroller and Auditor General for audit.

In accordance with this requirement, I have prepared the attached account of the amount expended in the year ended 31 December 2014 for the salaries and expenses of the Office of the Comptroller and Auditor General.

The expenditure outturn is compared with the sums granted by Dáil Éireann under the Appropriation Act 2014, including the amount that could be used as appropriations-in-aid of expenditure for the year.

A surplus of €677,695 is liable for surrender to the Exchequer.

The Statement of Accounting Policies and Principles and notes 1 to 6 form part of the account.

Statement of Accounting Policies and Principles

The standard accounting policies and principles for the production of appropriation accounts have been applied in the preparation of the account.

In addition, the following accounting policy has been adopted in respect of work in progress.

Work in progress represents the estimated recoverable value associated with audit work completed at year end in cases where an audit opinion has not been reported.

Statement on Internal Financial Control

Responsibility for system of internal financial control

As Accounting Officer, I acknowledge my responsibility for ensuring that an effective system of internal financial control is maintained and operated by the Office.

This responsibility is exercised in the context of the resources available to me and my other obligations as Accounting Officer. Also, any system of internal financial control can provide only reasonable and not absolute assurance that assets are safeguarded, transactions authorised and properly recorded, and that material errors or irregularities are either prevented or would be detected in a timely manner. Maintaining the system of internal financial controls is a continuous process and the system and its effectiveness are kept under ongoing review.

Significant financial risk

Audit fees are charged for certain financial audits in accordance with the Comptroller and Auditor General (Amendment) Act 1993. The fees form a significant proportion of the resources of the Office and a number of procedures have been put in place to ensure that costs are recovered for relevant audits. These measures include

- an annual review of the basis on which fees are charged including a review of the recovery
 of costs on individual audits over time
- systems which records audit costs, audit progress and billing information
- the monitoring of financial information including audit costs and fee recovery.

Financial control environment

A control environment containing the following elements is in place

- financial responsibilities have been assigned at management level with corresponding accountability
- reporting arrangements have been established at all levels where responsibility for financial management has been assigned
- formal procedures have been established for reporting significant control failures and ensuring appropriate corrective action
- there is an Audit Committee to advise me in discharging my responsibilities for the internal financial control system.

Administrative controls and management reporting

A framework of administrative procedures and regular management reporting is in place including segregation of duties and a system of delegation and accountability and, in particular, that

- There is an appropriate budgeting system with an annual budget which is kept under review by senior management.
- There are regular reviews by senior management of periodic and annual financial reports which indicate financial performance against forecasts.
- A risk management system operates within the Office.
- There are systems aimed at ensuring the security of the ICT systems.
- There are appropriate capital investment control guidelines and formal project management disciplines.
- The Office ensures that there is an appropriate focus on good practice in purchasing and that procedures are in place to ensure compliance with all relevant guidelines. The Office complied with the guidelines with the exception of one contract to the value of €46,000 listed in my annual return in respect of circular 40/2002. As this Office is due to vacate premises in 2015, it extended the contract for cleaning services at the existing rate for a period of 19 months or until the Office vacates the current premises. Prior to extending the contract a check on prices disclosed that the price was competitive and represented value for money. A new tender competition will be held for cleaning services prior to the move to new premises in 2015.

Internal Audit and Audit Committee

The Office has an internal audit function which operates in accordance with a written charter which I have approved. Its work is informed by analysis of the financial risks to which the Office is exposed and its annual internal audit plans, approved by me, are based on this analysis. These plans aim to cover the key controls on a rolling basis over a reasonable period. The internal audit function is reviewed periodically by me and by the Audit Committee. I have put procedures in place to ensure that the reports of the internal audit function are followed up.

The internal audit function is provided by a private firm which uses appropriately trained personnel.

Opinion to the Comptroller and Auditor General in accordance with Section 13 of the Comptroller and Auditor General (Amendment) Act, 1993

As the auditor appointed under Section 13 of the Comptroller and Auditor General (Amendment) Act 1993, I have audited the Appropriation Account of the Office of the Comptroller and Auditor General for the year ended 31 December 2014.

This report is made solely to the Comptroller and Auditor General, in accordance with Section 13 of the Comptroller and Auditor General (Amendment) Act 1993. My audit work has been undertaken so that I can state to the Comptroller and Auditor General those matters I am required to state to him in my opinion and for no other purposes. To the fullest extent permitted by law, I do not accept or assume responsibility to anyone other than the Comptroller and Auditor General, for the audit work, for this report, or for the opinions I have formed.

Respective responsibilities of the Accounting Officer and the Auditor

Under Section 22 of the Exchequer and Audit Departments Act 1866, the Accounting Officer is responsible for the preparation of the Appropriation Account. He is also responsible, inter alia, for the safeguarding of public funds and for the regularity and propriety of all transactions in the Appropriation Account.

It is my responsibility to audit the Appropriation Account in accordance with relevant legal and regulatory requirements and International Standards on Auditing (UK and Ireland).

I report to you my opinion as to whether the Appropriation Account properly presents the receipts and expenditure of the Vote for the year ended 31 December 2014. I also report to you whether in my opinion proper books of account have been kept by the Office. In addition, I state whether I have obtained all the information and explanations necessary for the purpose of my audit and whether the Office's Appropriation Account is in agreement with the books of account

Basis of Opinion

I conducted my audit of the Appropriation Account of the Office of the Comptroller and Auditor General in accordance with International Standards on Auditing (UK and Ireland) issued by the Auditing Practices Board and Section 3 of the Comptroller and Auditor General (Amendment) Act 1993. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the Appropriation Account, of whether the transactions recorded in the account conform with the authority under which they purport to have been carried out, and of whether the accounting provisions of Public Financial Procedures have been complied with.

I planned and performed my audit so as to obtain all the information and explanations that I considered necessary to provide me with sufficient evidence to give reasonable assurance that the Appropriation Account is free from material misstatement whether caused by fraud or other irregularity or error. In forming my opinion, I also evaluated the overall adequacy of the presentation of information in the Appropriation Account.

Opinion

In my opinion, the Appropriation Account of the Vote for the Office of the Comptroller and Auditor General properly presents the receipts and expenditure of the Vote for the year ended 31 December 2014 and there are no matters on which I need to report, pursuant to Section 3(10) of the Comptroller and Auditor General (Amendment) Act 1993.

I have obtained all the information and explanations which I considered necessary for the purposes of my audit. In my opinion, proper books of account have been kept by the Office of the Comptroller and Auditor General. The Appropriation Account is in agreement with the books of account.

Significant variations

The overall saving on expenditure headings in the year was €752,000. The main areas where savings occurred were as follows:

Salaries, wages and allowances

There was an underspend of €386,000 which mainly arises from replacement audit staff commencing on a lower salary point.

Travel and Subsistence

There was an underspend of €133,000 on official travel undertaken due to 2014 interim audits not advancing to the level anticipated and expenditure in relation to current year audit programme being less than budgeted.

Consultancy Services

The estimate provision for consultancy services was €350,000 of which €200,000 relates to a saving on the consultancy budget for National Asset Management Agency (NAMA). A corresponding €200,000 is included within the appropriations-in-aid budget as any such consultancy spend is recoupable from NAMA. The outturn was €2,000. The Office uses external expert consultants, if required, to assist in examinations carried out at the direction of the Comptroller and Auditor General. It is difficult in advance of decisions to undertake examinations to estimate the consultancy input that will be required. A business case review is prepared, setting out the reasons why a consultancy input is required, in advance of a contract being put in place.

Contract Audit Service

In compliance with Public Financial Procedures and with the sanction of the Department of Public Expenditure and Reform, a financial process known as virement was used in 2014. This allowed for savings on subhead (vii) Consultancy of €107,345 and €100,000 on subhead (ii) Travel and Subsistence to be used for additional expenditure of €207,345 on subhead (ix) Contract Audit Services to facilitate the timely certification of the final accounts of county enterprise boards and vocational education committees.

5.2 Remuneration of Comptroller and Auditor General

The salary of the Comptroller and Auditor General is paid directly out of the Central Fund of the Exchequer, as provided for in Section 14 of the Comptroller and Auditor General (Amendment) Act 1993. The charge on the Central Fund in 2014 in relation to the remuneration of the Comptroller and Auditor General was €175,742 (2013: €182,800). As provided for in Article 33 of the Constitution, the Comptroller and Auditor General may not hold any other office or position of emolument.

5.3 Remuneration of the Accounting Officer

The charge to the Vote in 2014 in relation to the remuneration of the Accounting Officer was €130,799 (2013: €135,630).

5.4 Acting up allowances

Two staff received acting up allowances for taking on the roles of higher grades. The total cost was 2,296 (2013: 35,935).

5.5 Re-engagement of Retired Officer

A total of €22,842 was paid to two retired civil servants, in receipt of civil service pensions, who were re-engaged on a short- term basis. One was re-engaged to aid in the review and clearance of audit files and the other was re-engaged to pilot an organisational performance review.

The payments made were consistent with the principles of the Pensions (Abatement) Act 1965. The Act provides that the pensions of former civil servants who are re-employed after retirement are abated to ensure their total pay in the period of re-employment does not exceed the remuneration they would have received if they had remained in the posts they held on the last day of their reckonable service.

6 Miscellaneous

Audit Committee costs amounted to €2,055 in 2014 (€4,000 in 2013).
